After the resolution is made during a meeting, a Corporate Resolution document is typically used to get the specifics of the resolution in writing.

Resolutions / How To Write A Resolution

A resolution is a main motion that needs to be expressed formally in writing, to attach a special level of importance. Because of the form — beginning with the word Resolved and following with either a statement of opinion or a statement authorizing or directing some action — such a motion is called a resolution .

1. “Resolved” should be in italics with a comma after it. 2. If the resolution is addressed to or refers to a specific group or groups, it must name in full (for example, American Library Association) the group or groups in both the “resolved. and “whereas.

Sample of Resolution Format - American Library Association

A delegate from your Home and School will present your Association's resolution. The resolution must be seconded by another registered delegate; seconder does not have to be a member of the presenting local. The presenter then has an opportunity to speak to the resolution. Questions/comments follow from the floor . Each speaker may only speak once.

Your resolution must adhere to federal and state laws, so be sure to do a thorough check to make sure no laws would be violated. Establish your authority. Make sure that your community’s governing documents provides your board with the authority to create new resolutions. Do your research.

6 Steps To Create An HOA Board Resolution

A Directors' Resolution is also referred to as a Consent to Action Without Meeting. It can be used in place of a corporate meeting to formally record the binding decisions of the board, so long as all directors agree and authorize the resolution.

A board resolution may also be referred to as a corporate resolution. Resolution is a form of the word resolve, which means to settle or find a solution to a problem, dispute or contentious matter. It also means to decide firmly on a course of action. Boards often use a sample board resolution as a template when they begin writing a resolution.

State the responsibility of the board with regard to the resolution subject in the second sentence. This establishes the board's right to take the action. For example, "Whereas, the board is responsible for approving (state action here)" is a possible second sentence.

Any delegate in the committee can write a resolution (although in rare instances an observer state is not allowed to directly write a resolution). The author of a resolution is called a sponsor. Most resolutions have multiple sponsors because it takes a group of countries to share good ideas and to come to a consensus.

For instance, you would have the following heading: "Board Resolution of [your company] passed on [date of resolution]".
